

1. Payment of Charges – Storage bills are payable monthly in advance for each month's storage thereof. Payment must be received by the 1-th of every month. Your credit card will be automatically charged every month on the 1-st of each month.

2. Termination of Storage – Global Moving Systems (the Company) reserves the right to terminate the storage of the goods at any time by giving customer (Depositor) thirty (30) day written notice of its intention to do so, and, unless the Depositor removes such goods within that period, the Company is hereby empowered to have the same removed at the cost and expense of Depositor, or the Company may sell such goods at auction in accordance with state law.

3. Change of Address and Contact Information – Notice of change of address and/or contact information must be given to the Company in writing and acknowledged in writing by the Company.

4. For your protection Global Moving Systems warehouse is a secured facility. Access is guaranteed by appointment only. A \$35.00 fee will be charged to your account for each visit. Vacating premises requires minimum one week notice; subject to availability.

5. We also charge a one (1) time rental fee of \$7.00 per moving blanket that is used to protect your belongings while they are in storage.

6. If we are unable to authorize the payment you'll be charged a \$35.00 penalty fee plus late payment fees. If the Due date falls on a weekend or a holiday, Global Moving Systems reserves the right to charge the credit card on file up to 2 days prior weekend or holiday regular scheduled payment and that there are no refunds at any time for any reason.

NOTE: you must give us a written notice regarding move-out from our warehouse prior to the 4-th of the month, otherwise you'll be charged for the full month and there are will be no refunds or prorates at any time for any reason.
